### Strategic Highlights

During the past year we also moved our scholarship funds from the National Association of Litho Clubs back to our local control here in Ct as we petitioned the State and Federal Government for 501c3 status. This will allow local control of the monies. The National Chapter of Litho clubs has been dysfunctional for the last several years.
